Reports -

- Treasurer Report (David P.) To be sent.
- Transport Troy Update (Pam) No November Transport Troy meeting. Report from the Uncle Sam Trail "river promenade" is that it is very nice to ride.

Old Business -

- Albany Bicycle/Pedestrian Master Plan (Ed, all) Draft plan due from the city in November. Ed will follow up with Planning office Status on promised follow-up meeting with Albany Common Council.
- CapitalNYBikeMap Enhancements (Glenn) Implemented new route from MHBHT,
 Watervliet, through Schuyler Flatts Cultural Park to Albany Rural Cemetery. All set for map
 presentation at CDTC's 12/8 Bicycle and Pedestrian Advisory Committee meeting with an
 emphasis on how the CapitalNYBikeMap helps activate the CDTC Trails Master Plan. Will see
 if participants will put a map link on their websites/Facebooks.
- MHBHT Root Damage (David) DOT and Albany County totally nonresponsive. David is drafting letters to Assembly members Fahy, Steck, and McDonald to (1) outline our efforts and (2) call for them to provide both impetus and funds to repair the MHBHT surface from Corning Riverfront Park to the Cohoes city line. John maintained that some sections have been repayed – where are they?
- **Patroon Greenway Project** (All)) City of Albany Patroon Greenway Project proposal (8/7/20) requested from Albany no response to date. Deputy Director at Plannning wants to review ABC's ride data. The suggestion was made to draft a letter to the city on ABC's involvement and to share the letter with those who endorsed the grant proposal.
- Bicycle and Pedestrian Advisory Committee (John) Did not attend. Meeting notes sent to the Core. Hoosick Hillside Study presentation recommended: traffic calming on 15th Street including curb extensions; a median on Hoosick Street between 8th and 10th; path connections from Hillside South; path connections between 8th and 10th; a traffic calming toolbox; reduced cut-through traffic; make 9th two-way for vehicles; a pedestrian crossing at 8th St and Hoosick; traffic calming on 8th and near Riley Park; a new connection via Rensselaer St with a street or path; 6th Ave Complete Streets accommodations including bike lanes; and a Park under the Collar City Bridge along Hoosick Street.
- Western Ave. Traffic Calming Lorenz to send a final letter to the mayor on Western Ave.
 Traffic Calming, closing Washington Park lake road, and Clinton Ave. bicycle lane rehabilitation.
- Connector Enhancements (9/17 email) –Mark will prepare email/letter to send items to
 Albany Common Council members Ward 1 Sonia Frederick and Ward 2 Derek Johnson and
 others who are supportive of a community-level asset. May meet with them and others for
 support for safety-related issues with the South End Connector.
- **Hudson AirBnb for People on Bicycles** (https://airbnb.com/h/brickbarnhouse) David responded on behalf of ABC on this initiative. Also sent FYI to Empire State Trail staff.
- RiseUp Enhancements (Glenn) All issues with ABC distribution lists addressed.

- Crash Reporting (APD) (Lorenz) The following information sent to our bicycle list on 11/19: "Bicycle-Motor Vehicle Crashes and Hit-and-Run Albany Police Department report If you are a victim of a crash, be sure to summon an Albany Police Department officer. If the event is in another jurisdiction, contact appropriate law enforcement. Call 911 or in Albany (non-emergency) (518) 438-4000. Insist that an "accident" report (DMV104A) is completed. If one is not, go to an APD (or other) station and complete the form there or complete the form on line at <a href="https://www.uslegalforms.com/form-library/39402-ny-mv-104-2011?msclkid=32706d365fed11ba8d4032833c2d98b1&utm_source=bing&utm_medium=cpc&utm_campaign=US_NY%20RMV%20Forms%20(new)&utm_term=%2Bnys%20%2Bdmv%20%2B104a%20%2Bform&utm_content=*2011%20NY%20MV-104,%20%5B2011-05%5D .
